The design will be used for embroidery so keep the small text and designs to a minimum or you may not be considered. The designer of the winning logo will receive a FREE Javelin Odyssey 10th Anniversary edition. That's right; your glasses are not fogged up. We said free, as in no money down, or ever. Get it? Good. Go to www.sunpath.com to download rules and release form. The winning design will be unveiled at the 2011 PIA Symposium in Reno, NV February 14th thru 18th 2011.

Contest rules:

1. Your design can be based on the current Javelin Odyssey logo and can be as many as 10 colors. The current logo is available in .eps, .jpg or .pdf format from the Sun Path marketing dept. E-mail contest@sunpath.com for a link to download them.
2. The words Javelin Odyssey and some reference to 10 years must be incorporated into your design.
3. Enter as many designs as you want. Each entry must have a separate signed release form.
4. Entries should be titled using the artist's last name and a sequence number.
5. Winning design must be available in .eps format ready to be digitized for embroidery but can be submitted in any common low resolution format.
6. Entries may be submitted via e-mail to contest@sunpath.com or by disk sent via USPS, UPS, and FedEx etc.
7. File size of your actual design is unlimited however please limit your submission to 2 MB or less for viewing by our judges.
8. Your artwork only. You may not submit a design you did not create.
9. Contest is not open to Sun Path employees, their families or fully sponsored athletes.
10. The design must fit in a rectangular area 8" wide x 3.25" tall.
11. Entries must be received no later than November 30th 2010.
12. There will be one winner. Compensation for the winning design will be a free Javelin Odyssey harness container system with options. No other compensation will be offered or is negotiable.
13. All entries will be considered by the staff of Sun Path Products Inc. and its designees. The winner will be announced at the PIA Symposium in Reno NV, February 14-18 2011.
14. You do not need to attend the symposium for your design to be chosen as the winner.
15. This contest is open worldwide however all contestants must be 18 years of age and a licensed skydiver regardless of where you reside. Proof of each will be required with entry.
